Mr. Nash led the pledge of allegiance and Mr. Gil delivered the invocation.

CALL TO THE PUBLIC

Mr. Nash opened the call to the public at 7:01 p.m.

FIRE CHIEF'S REPORT/SUMMARY OF CURRENT EVENTS

Chief Miller informed the board that the annual awards banquet will be March 19, 2016 at the Manda Le.

We're going to be working with the Palominas Fire District on a new program where we will utilize Per Diem Firefighters. We will be able to pull off duty full-time Firefighters and Reserves from each agency to backfill for overtime and other types of leave. We are holding off on hiring for full time positions that were mentioned last month, as we are currently waiting for our new assessed valuations to come in, approximately in February. We don't want to bring people on and risk

having to lay them off if our values drop significantly. We're hoping to expand this program to other agencies throughout the county. We'll be saving money on overtime costs, benefits, initial training and personnel protective gear by sharing resources. This program also allows us to work with members of other departments that ultimately may apply for openings within the District, affording us to opportunity to evaluate them prior to hiring.

Engine 361 was sent to Phoenix for upper & lower ball joints, control arm and new Vehicle Interface Module (computer); the cost is expected to be just around \$10,000 and will be ready at the end on the month.

Mr. Nash received a phone call from Mr. Jones, a retired member of the District, regarding his father's funeral. BC Seamans took care of the arrangements for the services and we had representation in attendance on behalf of the District.

We had 792 responses for the month of November.

FINANCIAL REPORT

A. Review, discussion and possible action on the monthly financial reports for November 2015.

Maria presented the Board with account balances as of November 30, 2015, along with a copy of the report from the Cochise County Treasurer's Office and the bank reconciliation from the District's Cyma Accounting Software. The District had \$938,039.11 in available operating funds as of November 30.

Ms. Banister made a motion that the board agrees to the balances presented for the month of November 2015. Mr. Barnett seconded the motion.

B. Review and discussion for the warrants issued for the month of November 2015.

Mr. Barnett asked what the checks to Applied Rite Doors and RWC International were for. Applied Rite Doors is for a new motor for the tender bay door at station 365 and RWC International was for engine 365 repairs.

Mr. McMurtrie asked what the checks for Cindy Elbert Insurance Services, Fire Etc., and Wicked Limitz were for. Cindy Elbert Insurance Services is our vehicle, building and liability insurance, which is paid quarterly, Fire Etc., is clothing for our personnel, and Wicked Limitz is also clothing/uniforms (shirts, sweatshirts, hats, etc.) for personnel.

Mr. McMurtrie made a motion to accept the regular meeting minutes of November 18, 2015, as presented. Mr. Gil seconded the motion.

Chief Miller attended the second hearing on HB 2162 on November 24th. The committee will have a recommendation by December 15, 2015 for both the Senate and House.
